DAUPHIN COUNTY, PENNSYLVANIA**

ORDINANCE NO. 2018-01

**AN ORDINANCE OF THE TOWNSHIP OF WICONISCO
REQUIRING THE PERMITTING OF ANY DUMPSTER
PLACED WITHIN THE TOWNSHIP OF WICONISCO**

BE IT ENACTED AND ORDAINED BY THE Board of Supervisors of the Township of Wiconisco, Dauphin County, Pennsylvania, in accordance with the powers granted by the Second Class Township Code as follows:

SECTION 1. TITLE.

This Ordinance shall be known as the "Wiconisco Township Dumpster Ordinance".

SECTION 2. PERMIT REQUIRED.

No person shall place or cause to be placed upon any street, sidewalk, alley or public right-of-way within the Township of Wiconisco any trash or refuse containers commonly known and referred to as dumpsters, without first having obtained a permit from the Township of Wiconisco. It shall be the responsibility of the user of the dumpster to obtain a permit and to provide a copy of such permit to the owner of the dumpster before placement of any dumpster.

SECTION 3. PERMIT APPLICATION.

A permit application shall be submitted to the Township on an application form provided by the Township for this purpose.

SECTION 4. PERMIT FEE AND DURATION.

Upon approval of the permit application by the Township, a permit for placement of the dumpster shall be issued by the Township upon payment of the permit fee. Permits shall be good for a period of thirty (30) days from the date of issuance thereof. Provided that the permit holder has complied with the requirements of this article and the permit issued hereunder, the permit

may be renewed for additional periods of thirty (30) days upon payment to the Township of a renewal permit fee for each thirty (30) day period. The permit fee and permit renewal fee shall be initially set at \$5.00 for each thirty (30) day period. Any change in the permit fee by the Township may be done so by resolution from time to time.

SECTION 5. PERMIT CONDITIONS.

Upon issuance of a permit as set forth herein, the permit holder agrees to comply with the following requirements:

- a. Any dumpster for which a permit is issued as set forth in this ordinance shall bear reflectorized or illuminated marking in order to provide adequate warning of the placement of such dumpster to pedestrians and motorists.
- b. After any dumpster is filled to capacity, the same shall be emptied or caused to be emptied within three (3) calendar days thereof.

SECTION 6. PERMIT REVOCATION.

Any permit issued or renewed by the Township as provided herein may be immediately revoked by the Township upon mailing of notice of revocation to the permit holder at the address stated in the permit application, for any of the following reasons:

- a. Failure to comply with any provision of this ordinance or any requirement as set forth in the permit or permit application.
- b. The emission of any foul or noxious odor from material contained in the dumpster, regardless of whether the dumpster is filled to capacity or not.
- c. The presence of any vehicular, pedestrian, fire, health or safety hazard or potential hazard arising after issuance of a permit or renewal thereof.

SECTION 7. PENALTY.

Any person violating any provision of this article shall upon conviction thereof, be fined not less than three hundred dollars (\$300.00) and not more than six hundred dollars (\$600.00) and costs of prosecution, and in default of payment thereof, shall be imprisoned for not more than ninety (90) days. Upon revocation of any permit granted or renewed hereunder by the Township, failure to remove any dumpster for which a permit has been revoked shall constitute a separate violation for each day after revocation. For each day that a dumpster is placed as provided herein without having obtained a permit therefore, a separate violation shall exist.

SECTION 8. ENFORCEMENT.

The responsibility for enforcement of this ordinance shall be the designee by the Board of Supervisors.

SECTION 9. GENERAL PROVISIONS.

If any section, subsection, paragraph, sentence, clause or phrase of this ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining provisions.


